

Bharti Hexacom Limited Transcript of 30th Annual General Meeting Wednesday, August 20, 2025, from IST 11:00 AM to IST 12:50 PM

- Welcome shareholders. 30th Annual General Meeting of Bharti Hexacom Limited is being conducted through videoconferencing. Requisite quorum being present. The meeting is called to order.
- With the permission of the members, the notice Boards report and Auditor's Report are taken as read. I now hand over the proceedings to the Chairman. Over to you, Chairman..

- Thank you. Good morning. It is my pleasure to welcome all shareholders to the 30th AGM of Bharti Hexacom Limited.
- We are pleased that all the Directors could join.

- Representatives of statutory auditors, secretarial auditors, and scrutinizers are also attending.
- I would like to start by taking you through the various remarkable phases and milestones in the journey of your Company. The market performance of the Company has been great. It has delivered substantial value to shareholders in the



financial year 2024-25, which is the first full year of Bharti Hexacom Limited as a listed entity and delivering phenomenal stock market performance. On 12th April 2024, 15% of the Company's equity was offered for sale at ₹570 per share through an initial public offer. From listing till the end of financial year 2024-25, your Company has delivered a return of 79% and on the IPO offer price of ₹570, the return stands at 156%. The Company has emerged as a preferred telecom mid-cap stock achieving a market capitalization of ₹72,870 crore on 31st March 2025, nearly a twofold increase from the time of listing.

- The Indian economy continues to be on a strong footing and India remains the fastest growing major economy in the world. The growth is supported by improved domestic consumption, structural reforms, and an increase in government spending across key sectors, including infrastructure, logistics, and welfare schemes. The government remains committed to fuel the digital economy of the country, which is reflected in robust economic growth. In parallel, the sector regulator, TRAI came up with forward-looking regulations to make the telecom sector even more resilient. As a contributor to India's development, Bharti Hexacom has paid over ₹83 billion to the exchequer through taxes, regulatory fees, and spectrum charges, reinforcing its role in India's economic development. Moreover, your Company prepaid all the liabilities pertaining to spectrum purchases done prior to 2021.
- Rajasthan and the Northeast regions except Assam, where Bharti Hexacom operates, have exhibited strong growth momentum, leading to higher than national average growth rates.
- The government of Rajasthan outlined the road map towards building a \$350 billion economy by 2030, and the Northeast is emerging as a hub for digital transformation with efforts of state governments, both manufacturing and industrial growth expanding together with bolstering the infrastructure, connectivity, and tourism in the region.
- The telecom sector plays a pivotal role in bringing the rural-urban digital gap down, bridging the rural-urban digital gap, driving digital adoption beyond major cities. In the regions where Hexacom operates tele density improvement offers sustained sustained growth potential for the future.
- Amid the strong economic growth Bharti Hexacom is playing an integral role in the progress of the digital economy in both Rajasthan and Northeast telecom circles, with continued investments aimed towards building a future ready, resilient, and secure digital infrastructure.
- Over the last five years, it has invested over ₹50 billion in strengthening its digital infrastructure. This includes acquiring an additional 15 MHz spectrum in subgigahertz and midband frequencies in these circles to further turbocharge our network. To augment digital infrastructure even further, your Company has been investing in 5G networks, which are expected to revolutionize the connectivity over the speed of time, alongside with the emergence of new use cases. The potential for monetization of 5G will be driven by emergence of large-scale use cases to enhance customer engagement and involvement in them.



- Nevertheless, 5G is expanding the addressable market for home connectivity already. The adoption of fixed wireless access given the low penetration of fixed line broadband in Rajasthan and Northeast, if FWA is expected to amplify the adoption of high-speed home Internet in the years to come.
- Bharti Hexacom as you know is part of the Bharti Airtel Group and iconic leader in the telecom domain in India and benefits from access to its advanced digital infrastructure, a converged suite of offerings including postpaid, Wi-Fi, DTH, OTT, and the highly experienced management team with an extensive tower network. With the constant aim to improve customer –India's first Al powered spam detection tool for its customers. Since the launch, this tool has identified 2.5 billion calls and 182.5 million SMSs as spams.
- The operational highlights of the Company have also been circulated, delivered sharp execution of simple yet focused strategy and sustained operational excellence marks this area. Our customers are at the center of everything we do, driving us to continuously in the weight and deliver brilliant experiences at every touch point coupled with razor sharp execution. This has enabled robust operational performance with sustained revenue market share gains in both Rajasthan and the Northeast circles.
- In the financial year 2024-25, your Company further cemented its leadership in the Northeast, where it has been a leader for some time and made significant gains in Rajasthan with the combined revenue market share of nearly 46%, gaining 6 percentage points in the last three years.
- Your Company has delivered industry-leading ARPU growth in financial year 2024-25, which is a remarkable achievement.
- In the last three years, the Company has added nearly 4 million customers, reaching 29 million in all, while sustainably growing its smartphone and data customer base.
- Further, the 5G adoption is also picking up with millions of customers already enjoying your companies 5G plus network.
- Under its rural acceleration program in the last two years, your Company has expanded coverage across more than 6,000 villages, bringing to them the benefits of connectivity, digital commerce, and payments.
- Your Company has also accelerated Wi-Fi expansion by deploying fiber to the home passes and rolled out home broadband with fixed wireless access technology in underserved area.
- In the area of ESG also, your Company is focused to grow sustainably and minimize impact on the environment and our efforts are reflected in initiatives like greening the network, optimizing diesel consumption, and improving site solarization.
- Solar axis has expanded to about 5,000 towers and we have during the year achieved diesel savings of 41,522 kilo liters through energy conservation measures.



Today, over 48% of our sites are green and renewable energy usage is up 350% compared with last year.

- The Company also aims to champion diversity with its extended support for women through policies which cater to a wide variety of requirements including fertility treatment coverage, safe late-night travel, and women's specific leadership training, and this is beginning to make a difference. Your Company takes pride in integrating best practices across the organization and maintaining the highest standards of governance and transparency.
- In the arena of Corporate Social Responsibility, Bharti Hexacom proudly supports the Bharti Airtel's Scholarship Program, benefiting 247 engineering students from India's 50 leading NRF ranked institutes, around 20% of these scholars are talented young women, and this is the first year of this operation. The initiative is designed to support talented students from a wide range of socioeconomic backgrounds, particularly young women become tomorrow's technology leaders.
- Coming to the financials on the balance sheet: your Company's remarkable
 performance during the year was underpinned by its consistent focus on winning with
 quality customers, delivering a brilliant experience and driving operational excellence.
 Through this approach, your Company attained industry-leading revenue growth and
 strong operating leverage resulting in further strengthening the balance sheet.
- In the financial year 2024-25, it delivered revenue of ₹85,479 million, up 21% year-to-year and the EBITA after lease was ₹37,789 million, up 27% year-to-year. EBITDA after lease margin stood at 44.2% vs. 42.1% last year.
- On the back of the stellar financial performance, the Board has recommended a dividend of ₹10 per fully paid-up equity share of face value of ₹5 each which is a two and half time increase over the dividend last year.
- Lastly, I'm pleased to mentioned changes in the Board's composition and pleased to welcome Mr. Rakesh Bharti Mittal and Mr. Kanwaljit Singh Cheema as members of the Board. To summarize, this year marks a defining chapter for Bharti Hexacom Limited, our first year as a listed Company, with remarkable progress both across operational and financial domains. From delivering strong shareholder returns and financial performance to accelerating digital inclusion across Rajasthan and the Northeast, your Company is committed to provide brilliant experiences to its customers. We will continue to invest to deepen our footprint, future proof our digital network, leverage digital tools from Bharti Airtel to deliver superior customer service and experience.
- To conclude, I wish to express my sincere gratitude to all our shareholders for their enduring trust and support, including TCIL, which is a major shareholder of 15%. As we move forward, we do so with deep confidence in our strategy, a clear focus on execution, and commitment to delivering long-term value to our customers and shareholders. The foundation that we have built this year sets us on a path of transformational growth. Thank you all for your attention.



- I now request Akhil Garg, our Chief Financial Officer, to brief the members of the Company's financial performance during the financial year to 2024-25.
- Mr. Akhil Garg -- Chief Financial Officer, Bharti Hexacom Limited:
- Thank you, Chairman.
- Good afternoon, shareholders.
- First of all I would like to welcome all the shareholders to this AGM. Following the last year's remarkable landmark IPO, we completed our first full year as a listed Company, delivering strong operational gains and healthy financial results. Your continued faith in Bharti Hexacom has been central to this progress. Let me give you some details about the Company's performance for financial year 2024-25. The Company ended the year with 28.6 million customers, which is in addition of 0.9 million customers during the year.
- The Company added 2 million smartphone data customers. The data consumption per customer, per month reached at 27.7 GB, which is a 13% growth year-on-year.
- Our simple strategy to premiumize the portfolio by upgrading from 2G to 4G/5G, expanding data monetization, international roaming, and driving upgrade from prepaid to postpaid is working well. These measures along with the tariff repair which was taken in July 2024 have resulted in
 - an increase in average revenue per user, which is ARPU by ₹38.
 - With this, the ARPU has reached to ₹242 as on March 2025,
 - making it an industry leading ARPU growth.
- Strong execution of a strategy has enabled us to increase our revenue market share both in Northeast and Rajasthan circles. In Northeast, the revenue market share has increased by 685 bais point in last three years, thus reaching to 57.9% further consolidating our leadership position.
- In Rajasthan, during the same period, there has been an increase in revenue market share of 548 basis point, thus strengthening the market position with the RMS of 43.1% narrowing the gap with the market leader.

In both circles, your Company is at all time high revenue market share.

- Revenue for the year financial 2025 was reported at ₹85,479 million, which is a growth of 20.6% versus the previous year. EBITDA was reported at ₹37,789 million. EBITDA margin as a percentage of revenue was reported at 44.2% driven by robust financial performance, operational excellence, and cost optimization initiatives like war-on-waste. The Company has invested CapEx of ₹14,730 million in strengthening data and digital infrastructure. This enabled the Company to generate strong operating cash flow of ₹23,059 million. The return on capital employed, which is ROCE, has also shown a consistent improvement with the Company delivering a return of 17.7%. During the year, Company prepaid high-cost spectrum debt



amounting to ₹8,576 million. The Company also redeemed unsecured nonconvertible debenture amounting to ₹20 billion, thus resulting into a substantial improvement in net debt to EBITDAaL from 4.67 times in financial 2022 to 0.98 times in financial 2025, reflecting a prudent financial management.

- On the mobility segment, the Company ended the year with the customer base of 28.13 million of which 21.49 million were smartphone data customers, an increase of 10.3% vs. financially 2024. This has led to data consumption increase on a network by 27%, making it 6,238 PetaBytes.
- In homes and Office segment, the Company has increased its Wi-Fi coverage through FTTH and FWA rollout, extending access to underserved areas. Wi-Fi services are now available in more than 200 cities. The customer base stands at 448,000 as compared to 305,000 in financial year 2024.
- On the network site, the Company continues to enhance its network coverage across the regions with the focus on rural expansion. The number of network towers has increased from 25,700 to nearly 26,500 in financial year 2025. Similarly, the number of mobile broadband stations have grown from 79,850 to 81,850. We now cover 96.5% of the population. Continued investment in network infrastructure is aimed at delivering faster speed, higher capacity, building resilience, and provide superior customer experience.
- The Company has spectrum holding of unpaid of 2040 MHz; it is the largest holding in the mid bank spectrum in these circles. With this, the Company is well positioned to meet the data requirements. Our strategy is simple, win with quality customers, premiumize portfolio, drive digital innovation for operational efficiency, enhance customer experience, and deliver secure connectivity to our customers. We are enabling all this while keeping sustainability at core and eliminating wasteful expenditure.
- Let me give you some details about the strategies now. On quality customers and premium edition of portfolio, our postpaid customer base has seen a 20% increase in the last year, thus reaching to a 1.03 million base. Smartphone data customers account for 76.4% of the total mobile customers, an improvement of 500 basis point versus last year. On home segment, the focus is on expansion and coverage. These services are now available in more than 200 cities through FTTH and FWA.
- On innovation and secure connectivity, as Chairman suggested, Bharti Hexacom benefits from Bharti Airtel's robust digital infrastructure to drive both operational efficiency and greater value to its customers. The Company has launched India's first Al-powered spam detection tool, which identifies spam calls, messages, malicious links in real time providing a safer digital access to its customers.
- On war-on-waste, the Company has been actively implementing prudent cost optimization measures to enhance margins. War-on-waste is ingrained in the ways of working for your Company. It is underpinned by strong focus on simplification, improved efficiency, and productivity. Through war-on-waste program, Bharti Hexacom continues to drive efficiency by eliminating wasteful expenditure, thus resulting in enhanced profitability. The Company also expanded its green sites from



42% in financial 2024 to 48% in financial 2025. To sum it all, financial 2024-25 has marked an important step forward for Bharti Hexacom. Strong execution, sound capital Management, and targeted investment have reinforced our competitiveness and financial strength. As we look ahead, we will continue to focus on sustaining profitable growth, expanding our footprint, and delivering seamless and secure network to our customers.

- Good afternoon, Chairman Sir, Board of Directors, and Management team. I am MP Bhutani with Santosh Bhutani joining this meeting from New Delhi and I feel to be proud of a member of Bharti Hexacom. First of all, a big thanks to the team of CS for accurate commencement well in time.
- Our section has been covered in very lucid and transparent manner, annual report is very informative, and after going through the Annual Report and our Chairman speech, I am extremely confident that the Chairman and team of the Chairman will hit more significant milestone and to take the Company to the next piece of growth. My question is what strategy is the Company implementing to extend and enhance its network quality and expanding its five services across different regions ensuring seamless connectivity to its customer? #2, could the management provide insight into the Company plans for digital transformation and leveraging emerging technology to drive innovation, improve customer experience, and increase



operational efficiency? I feel very proud if you please explain more about your Company and I wish the Company all the best and hope to see a healthy growth in the business and size the Company. May God fulfill all your wishes and keep you all happy, healthy, and safe. Thank you very much, Chairman Sir. Thank you.

- Moderator:

- Thank you so much, Mr. Bhutani. Chairman Sir, our next shareholder, Mr. Ashok Kumar Jain, is not present in the meeting. So, we're now inviting Ms. Shashi Jain to speak. Ma'am, we have placed you in the meeting. Kindly unmute your microphone to speak.
- Ms. Shashi Jain Shareholder:
- Hello?
- Moderator:
- Ma'am, we can hear you. Please proceed.
- Ms. Shashi Jain Shareholder:
- Okay. Good afternoon, Chairman Sir. I Shashi Jain attending the AGM from Delhi. I am thankful to the management and secretarial department for providing me opportunity to express my views. Thanks to our CMD, Sir, for excellent speech regarding Company's performance. I am very happy to see the business growth of the Company. I also thanks to Company Secretary and his entire team to help me to join the meeting on VC. Most of my query cover under Chairman Sir speech. Even earlier speakers have raised many queries. My question is, any plan for right issue in the future? I support all the regulations. Thank you. Thank you so much, Sir.

Moderator:

- Thank you, Ms. Jain. Chairman Sir, putting on record that the last shareholder, Ms. Celestine Elizabeth Mascarenas, has not logged on to the meeting. So, with this, all shareholders who registered as speakers have now spoken and I hand over the floor back to you to conduct the further proceedings of the AGM. Over to you, Sir.
- Mr. Jagdish Sakena Deepak -- Chairman, Bharti Hexacom Limited:
- Thank you to all the shareholders who've expressed interest in the working of the Company and have asked specific questions. Let me go 1 by 1 and take some of the issues that have been raised and certain details related to the financial performance and other data would be provided by the CFO.
- Santosh Kumar Saraf Sahab ne pucha ki Company dwara technology ka istemal kis tarah se kiya ja raha hai, uska kya fayda hoga. To jaisa ki humne apni statement mein kaha tha, aapki Company katibadh hai ki technology ko leverage karke customer ko better experience provide karegi, aur isse jo services provide karne ki cost hai, use bhi kam karegi. To ek to hum 5G technology ka bahut bade star par istemal kar rahe hain, jisse broadband facility Rajasthan circle mein aur North East



circle mein – jo ki durast prakar ke circle hain – dene mein through fixed wireless access asani hui, aur isse hamara broadband reach badha hai.

- Dusri baat hai war-on-waste; efficiency increase karne ki baat hai, phir energy badhane ke hit mein renewable energy and green energy ka prayog kiya ja raha hai.
 Prayas kiya ja raha hai ki energy cost – jo ki kaafi mahatvapurn cost hai Company ke liye – usko kam karne ki koshish kari jaye.
- Teesra aur bahut mahatvapurn technology ka istemal hai: Humne Artificial Intelligence-based tool jo humne khud ijaad kiya hai, Airtel ne. Uska istemal karke customer ko warn kar rahe hain ki kaunsi call spam call hogi, kaunse SMS spam SMS hain, taaki wo unko avoid kar sake. Aur is financial year mein is Al tool ne 2.5 billion calls aur lagbhag 182 million SMS ko is tarike se flag kiya hai, jisse consumer ko unse door rehne mein sahuliyat hui hai.
- Shree Gagan Kumar ji ne sarahana ki dividend 2.5 times badha hai aur bhavishya mein kya hoga iske baare mein unhone utsukta bhi vyakt ki hai. To main ye aapko batana chahta hoon ki Company ki financial performance utkrisht rahi hai is financial year mein aur hume ummeed hai ki aage jaake samay mein bhi ye aur behtar hogi.
- Isiliye return to shareholder ke prati hum optimistic hain, aur jaise hi results aayenge aur achhe results aane ki hum sambhavna dekhte hain, waise hi Board aur management discuss karke dividend ghoshit karega. Aap jaante hi hain ki Company ki policy hai ki shareholders ko adhik se adhik rewards ghoshit kiye jaye, jiske anusar 2.5 times dividend is saal badhaya gaya hai.
- Sneh Sneh Mahanot ji ne pucha ki Al ka kis prakar se prayog ho raha hai? Punji ki vyavastha kis tareeke se hogi aur Trump tariff ka kya asar padega? Net profit ka kya percentage royalty hai? Last cheez to hamare CFO batayenge. Lekin jahan tak Board of Directors ki superintendence ki baat hai, diversified Board hai aur tamam tarah ki inke expertise ki baat hai, to ye inhe closely supervise and monitor karte hain jisse management team par supervision bhi ho sake aur inko support bhi mil sake. Punji ki vyavastha ke sambandh mein hum koi bhi issue forecast nahi karte. Financial performance achhi rahi aur aapne dekha hai ki is saal humne saara spectrum jo installments se 2021 purv se jo high interest rate par tha, wo sab prepaid kar diye. Aur cash flows jo aane ki sambhavna hai, Company ka kaam chalane ke live aur dividend dene ke live paryapt honge.
- Trump tariff ka jahan tak sawal hai, ye tariff custom duty hai jo goods par or merchandise trade par lagayi jati hai, par aapki Company services provide karti hai.
 Atah Trump tariff se iske karya par koi bhi effect padne ki sambhavna nahi hai.
- Shree Ankur Chanda ne renewable energy aur green energy ke baare mein pucha. The Company is committed to expanding the use of green energy, both through open access as well as through solarization of sites.
- Jahan tak solarization of sites ki baat hai, 48% of our sites jahan tak feasible hai, jahan tak ho sakta hai, kaam wahan tak ho chuka hai aur isse bahut adhik savings diesel ki hui hai aur cost bhi bahut kam hua hai. Going forward, we will continue to use renewable energy for reducing costs and for achieving our ESG goals.



- Shree Gaurav Kumar Singh ji asked about CapEx plan for the next two-three years, whether the same dividend would be paid and what is being done for ensuring retention of talent. About CapEx plan the Company is able to generate resources to make adequate investments in CapEx. Our focus has been on 5G rollout, which is almost complete as well as in going deeper in rural areas and reaching out to rural customers and for this, whatever CapEx is required will be done and continue to be done.
- As far as the dividend is concerned, I have already mentioned, we expect good performance, even better performance and the cash flows as well as the profitability of the Company should give us an opportunity to give very generous dividends as is the policy of the Company.
- Mr. Santosh Bhutani asked about regarding HR practices, sorry of your Company is rated very high as an employer and it also tries to implement the job practices as well as supportive supervision and employee friendly measures with the result that we do face attrition, we do face turnover, but it is well under control and the aspiration of both management and workers to join a Company which is from the Airtel stable is very high, so we do not have any problem in retaining talent both at the management level, the managerial level, as well as the worker level.
- Mr. Satish Bhutani asked about the strategy for improving network quality and plans for using for digital transformation. Now, as we explained, the 5G rollout has brought in the new technology and use cases. Certain use cases are already visible. Some more will come in and two areas where we've been able to implement, we will pass on the benefits of new technology to consumers as well in the warning against scams as well as in providing broadband access through fixed wireless access, and we continue to keep looking at various measures to further improve customer experience.
- Shashi Jain ji ne right issues ke bare me baat ki and usme liye mera answer dividend hai. The management as well as the Board will look and believe that customers need to be rewarded, that that shareholders need to be rewarded, and looking at the profits and the accretion of resources, at the relevant time take decisions on dividend or other ways of supporting of providing returns to shareholders.
- With this I will now pass on to the CFO for giving details on various financial aspects that have been asked.
- Mr. Akhil Garg -- Chief Financial Officer, Bharti Hexacom Limited:
- Thank you, Chairman Sir. On the CapEx, the Company has been very prudent in spending its CapEx. We have also demonstrated that with you know good operating free cash flow that is getting generated, the Company will continue to invest in CapEx wherever there is a need for growth and for network improvement and digital infrastructure. So, that will continue to grow our business to give better experience to our customers.
- On royalty, the Company uses the brand from Airtel and various digital infrastructure, which are being used from the Company, which are being used, which help our



Company to provide good experience to our customers. So, that is what it is being used for, for which royalty is paid. So, those are two questions which were pertaining to finance.

- Mr. Jagdish Sakena Deepak -- Chairman, Bharti Hexacom Limited:

One more question which I did not cover was regarding Starlinks. Now, satellite communication is a technology which will benefit consumers and soon it will be available in India once spectrum is allocated by the government and we are able to provide services. This is the Company, which is sort of start OneWeb has the authorization, has the license, and as soon as it gets spectrum, it will be able to provide satellite communication both in Rajasthan and in the Northeast, where it is required. The capacity this Company has over India is about 15 GBPS and we believe and from the demonstrations that we have done, it is basically in the B2B area and we will be able to provide satellite connectivity in remote areas, to defence forces, to relief operations, to maritime, to oil rigs, as well as to ATMs etc. in remote areas, So, that is one aspect wherein consumers both in Rajasthan and Northeast will benefit from satellite communication. As far as Starlinks is concerned, it's also rolling out. Its focus is mostly on business to consumer, lower cost terminals, and there also we have a partnership with Starlinks. We will be working as a reseller for their terminals and their connections as well, so we are firmly connected for ensuring the expansion of technology for consumer use and improved experience in remote areas through the low earth orbit satellite constellations. Thank you.

- Mr. Amit Chaturvedi -- Company Secretary, Bharti Hexacom Limited:
